## ELECTION NOTICE

*Fair Work (Registered Organisations) Act 2009*

The Delegate of the General Manager of the Fair Work Commission has made arrangements with the Australian Electoral Commission for elections to be conducted for the offices listed below.

- **Nominations**, which must be in writing and comply with the organisation's registered rules, may be made at any time from Wednesday 4 March 2015 and must reach the office or postal address of the appropriate Returning Officer **not later than 12 Noon (local time) on Wednesday 25 March 2015**. Nominations cannot be withdrawn after 12 Noon (local time) on **Wednesday 1 April 2015**.
- **Nomination Forms** for both Individual and Team Nominations are available from the relevant Returning Officer or the registered office of the organisation. The use of these forms is not compulsory provided that nominations comply with the rules.

In addition to Individual Nominations Rule 40.f allows for a group of eligible members to nominate as members of a "Team Nomination", which must have a name.

Rule 40.f.ii states - *The name of a Team nomination must not be the same as or similar to the name of another Team Nomination or the name of any member of another Team Nomination or be deceptive of any other way.*

A team nomination must nominate an eligible (or required number of people) for each position for which nominations have been called whereupon each person will be considered to have nominated for each position concerned.

- **Ballot:** If a ballot is required ballot material will be posted on Wednesday 22 April 2015 to eligible members at the address shown in the Union's records. The ballot will close at 10 am (local time) on Wednesday 13 May 2015.

**Members should notify the Union of any change of address.**

Note: A copy of the AEC's election report can be obtained from the Union or from the Returning Officer after the completion of the election.
